Gaps in Care Reporting

Alterwood Advantage continues to improve our HEDIS reporting capabilities. We have begun to share our HEDIS Gaps in Care Reports with our provider network. Insulin

Alterwood Advantage members' copay for a month of insulin is no more than \$35. This is applicable to <u>formulary insulins</u> that members self-administer with a syringe/pen (covered under Part D) or any insulin administered through an external insulin/infusion pump (covered under Part B). Our covered formulary insulins are listed in Alterwood Advantage's formularies found at www.AlterwoodAdvantage.com. Other insulins not listed in our formularies require a formulary exception and providers may call

Note: Members who receive <u>Part D</u> "Extra Help" (also referred to as Low Income Subsidy) will pay no more than \$10.35 (2023) and \$11.20 (2024) for a month supply of a formulary insulin. Extra Help does not apply to Part B coverage.

Vaccines

It's that time of the year! Alterwood Advantage members have no copayment for these vaccines.

The influenza (flu) vaccines during the 2023-2024 season will be quadrivalent (four components). The Centers for Disease Control and Prevention (CDC) and the Advisory Committee on Immunization Practices (ACIP) preferentially recommend adults 65 years and older receive one of the higher dose or adjuvanted influenza vaccines (**Fluzone** High-Dose Quadrivalent vaccine, **Flublok** Quadrivalent recombinant flu vaccine, and **Fluad** Quadrivalent adjuvanted flu vaccine). Ideally, the flu vaccine should be offered in September or October, but still appropriate throughout the season as long as the flu viruses are circulating in our community. COVID-19 continues to circulate in our communities. We are at risk as the virus continues to change and new variants emerge. The updated formula of the 2023-2024 COVID-19 vaccines is anticipated to work well against current circulating variants, including BA.2.86.

Respiratory Syncytial Virus (RSV) can be the cause of severe respiratory illness leading to hospitalizations and deaths. Alterwood now covers **Abrysvo** and **Arexvy**, the new vaccines for RSV in adults 60 years and older. Both are approved by the FDA as a single dose. The CDC recommends using shared clinical decision-making (SCDM) to assist in your discussions with your patients. Consider multiple factors such as your patient's risk of exposure to RSV and their underlying medical conditions that places them at increased risk.

Please reach out to your Alterwood Advantage patients about these important vaccinations (or discuss these vaccines with your Alterwood Advantage patients at their next visit this Fall). The benefits of these vaccines continue to outweigh any potential risks.
