

Dear Participating Provider:

To support our role in overseeing the quality of care provided to our members, improve the health of our members and meet CMS federal requirements, we collect HEDIS® (Healthcare Effectiveness Data and Information Set)* data annually. Provider participation is essential to the success of this process.

BACKGROUND: The majority of HEDIS information comes from claims; however, medical records are also incorporated into our data. The medical records chosen for review are based on statistically valid samples of members who meet criteria for inclusion in the HEDIS measure being reviewed. We rely on our provider partners to assist us in this medical record collection project.

<u>HOW YOU CAN HELP:</u> Alterwood Health has contracted with Ciox to collect and abstract the charts required for HEDIS measure reporting. Ciox will contact your office to schedule onsite, remote access, or fax/mail medical record collection between the date of this letter and May 3. We ask your office to accommodate this request for chart retrieval at the earliest mutually agreeable date. When the date for chart retrieval is confirmed, Ciox will fax instructions for the review and a list of members' charts needed, with measure-specific requirements.

<u>PATIENT CONFIDENTIALITY:</u> Alterwood Health and Ciox staff conducting medical record reviews will maintain the confidentiality of all medical information per HIPAA regulations. Alterwood Health members have already signed a medical record release at the time of their enrollment. There is no need to obtain this document from the member prior to sharing the medical record with Ciox.

MEDICAL RECORD SUBMISSION OPTIONS:

- 1.) Ciox Link Provider Portal (*Recommended method*): Upload up to 200 medical records to Ciox's secure provider portal at https://www.cioxlink.com. Username and Password credentials will be located on your Pull List that contains patient/measure information.
- 2.) EMR remote retrieval: Set up secure remote connection from a provider site's EMR directly to Ciox for timely off-site remote retrieval of records with trained associates at Ciox by contacting 1-877-445-9293.
- 3.) Onsite retrieval: Schedule on-site retrieval with a complimentary Ciox Retrieval Specialist or review any aspects of the on-site retrieval services at Ciox by contacting 1-877-445-9293
- 4.) Fax: Send secure faxes to 1-972-957-2222
- 5.) Mail: Mark 'Confidential' on the envelope and mail the medical records to:
